Dear Mr. Shippey:

The Nevada Pharmacy Alliance (NPA) and the American Pharmacists Association (APhA) appreciate the opportunity to submit comments on the Nevada Division of Insurance's (NVDOI) plans to update Nevada's essential health benefits (EHB) benchmark plan. We are supportive of the proposed changes to Nevada's EHB benchmark plan, however, we urge you to also include appropriate corresponding amendments to ensure pharmacist-provided preventative care services are a required benefit for Nevada patients.

As required by USC §300gg-13(a)(1), "evidence-based items or services that have in effect a rating of "A" or "B" in the current recommendations of the United States Preventive Services Task Force"<sup>1</sup> (USPTSF) are required to be covered by health plans with no cost-sharing requirements for patients. Additionally, women's preventative care and screenings, including contraception, as provided for in Health Resources and Services Administration guidelines<sup>2</sup>, are required to be covered by health plans with no cost-sharing requirements for patients. In August 2023, USPSTF finalized its recommendations on the prevention of the acquisition of HIV through pre-exposure prophylaxis (PrEP). Their Grade A recommendation states, "that clinicians prescribe preexposure prophylaxis using effective antiretroviral therapy to persons who are at increased risk of HIV acquisition to decrease the risk of acquiring HIV."<sup>3</sup>

During the 81<sup>st</sup> Legislative Session in 2021, Nevada passed Senate Bill (SB) 190<sup>4</sup> and SB 325<sup>5</sup> into law. These bills expanded pharmacists' scope of practice to allow them to prescribe and dispense medications for hormonal contraception and HIV pre- and post-exposure prophylaxis per protocols drafted by the Nevada State Board of Pharmacy. Despite substantial published literature, clearly documenting the proven and

significant improvement to patient outcomes<sup>6</sup> and reduction in health care expenditures<sup>7</sup> when pharmacists are optimally leveraged as the medication experts on patient-care teams, there have been historical gaps in health plans recognizing pharmacists as a provider type and reimbursing their services under the medical benefit. There is not currently a widespread ability for pharmacists to enroll as a provider type with Nevada's EHB plans to provide preventative care services to patients.

Given the requirements dictated in USC §300gg-13, and that pharmacists can provide preventative care services per their scope of practice in Nevada, we urge you to also include appropriate corresponding amendments to ensure pharmacist-provided preventative care services are a required benefit for patients.
